Submit the application. Processing time: 7 working days. To submit an EA licence application: Log in to GoBusiness Licensing to apply. Pay the \$400 fee online. When you get an IPA notification by email or SMS, log in to GoBusiness Licensing to download the IPA document. The IPA is valid for 4 weeks. Once it lapses, you must make a new application.
